Larry Lee spent 17 years in the NFL, 8 as a player and 9 as an executive. He participated in Super Bowl XXII while playing for the Denver Broncos. He then went on to become Vice-President of the Detroit Lions. After his NFL years, he decided to return to his childhood passion, music. He has been a professional bass player for more than 25 years. After getting his fingers back into shape, he formed the band "Larry Lee and Back In The Day" (LL and BITD). LL and BITD have comprised a resume that is second to none. In its short 4-year existence, LL and BITD has shared the bill with artists such as the Isley Brothers, Smokey Robinson, Little Richard, The O'Jays, Average White Band, The Temptations, Isaac Hayes, The Gap Band, Morris Day and The Time, Dave Koz, Los Lobos, KEM, Robert Randolph and The Family Band, just to name a few. LL and BITD was nominated as the "R & B Band of the Year" in 2005/2006/2007. Larry was the 2006 "Urban/Funk Musician of the Year".

Many consider Julian Pavone the "Tiger Woods of the Music Industry". At only 19 months old, Julian recorded his CD, "Go Baby!" He has appeared on many television shows, including "Good Morning America", "Martha Stewart", "Inside Edition", "MSNBC", "WGN", "FOX News Dayside", "Good Company", and locally, "Fox 2" and "WDIV 4". He has also received accolades in newspaper articles from every corner of the world. He has performed for the Detroit Pistons, Cleveland Cavaliers, at a VIP party for the Chicago Cubs season home opener, at the House of Blues, inspired the creation of Harmonie Network (a national entertainment and music company) and launched his own clothing line.


